Dhaka Transport Coordination Authority (DTCA) is the Transport Planning and Coordination Authority of the greater Dhaka. It has prepared the Transport Master Plan namely Strategic Transport Plan (STP) (revised and modified in 2015) which is the guiding document for all possible planning and transportation infrastructure development in Dhaka and adjacent districts. One of the major component of STP is to restructure, reorganize and rationalization of bus sector. Now DTCA would like to hire a Technical Consultant experienced in Public Transport especially in bus route rationalization for necessary supports.

2. Scope of Tasks/Service

The Dhaka Transport Coordination Authority (DTCA) is requesting proposals for a position of Technical Consultant for the Preparation of Concept Design & Implementation Plan for Bus Route Rationalization and Company based Operation of Bus Service in Dhaka Project. The consultant will be exposed to a wide range of urban transport issues with primary focus on bus route rationalization in Dhaka and will to provide adequate support to DTCA officials.

The selected individual will:

- Assist in planning, pre-feasibility, feasibility and other phases of the development of Bus Route Rationalization;
- Prepare necessary documents on Bus Route Rationalization and attend meetings, present, take notes etc.;
- Coordinate with other relevant Transport Agencies for information collection, project updates, drawing collections and Review relevant literature, reports, researches and articles etc. Develop DTCA as a database and information center for bus operation (public transport) for the DTCA jurisdiction area;
- Assist in works to improve the overall public transport situation while phasing out NMTs from arterial roads, creating multimodal hubs, introducing TOD etc. Provide planned measures to be taken for modal shifting of trips towards public transport in Dhaka.
- Provide administrative, logistical and general office support for maintaining the plan, schedule, arrangement of events etc. and
- Assist DTCA officials for technical Support, technical analysis, mapping, data collection and presentation, report production and related activities;

3. Qualifications

The selected individual must:

- Have at least bachelor degree in Civil/ Transport Engineering/ Urban planning/ Architecture or in relevant subjects (Masters in Civil/ Transport Engineering/ Urban Planning/ Architecture or in relevant subjects will be preferred).
- Have an understanding of principal urban transport issues, particularly Public Transport issues of Dhaka and be prepared to work independently to conduct research. Have advanced abilities to obtain and display geographical and other data with high presentation standards.
- Have at least 5 years general experience and 2 years of experience of working in the transportation sector.
- Have strong skills of personal organization and administrative abilities and have high standards of spoken and written English. Having academic and other publications on related topics will be advantageous.

4. DTCA now invites eligible applicants to indicate their interest in providing the services. Applicants are invited to provide information indicating that they are qualified to perform the services (complete CV with other details as required as per the Application Forms).


